General Membership Meeting Minutes
Tucson Trap and Skeet Club
Tuesday, May 15, 2018

- President Christopher L. Naler called the meeting to order at 1606.
- The reading of the 2017 general membership meeting minutes were waived. A motion was brought to the floor by Dave Wood and seconded by Van Boerner. Motion carried.

Officers' Reports

1. President Chris Naler
 - a. Delivered the "State of the Association" report, including the attendance of the 2018 ASSC, noting that attendance is lower than years' past.
 - b. Discussed elections for Zone 9 (AFSA) and State elections to NSSA. Dave Wood, Chris Naler, Charles Thompson, and Katie Fichtner are up for election.
 - c. Thanked everyone for their attendances, participation, and assistance.
2. Vice President, Steve Johnstone
 - a. Recognized Katie Fichtner for her exceptional work on improving the AFSA website, creating a social media footprint for the association and bringing our digital footprint into the 21st century.
3. Treasurer, Andy Ulsher
 - a. Treasurers' Report was posted prior to the general membership meeting for all to view.
 - b. Discussed difficulty receiving shotguns from Remington because of a delay between order and receipt. Delay resulted in ordering of Remington R-1 1911s for the 60th ASSC instead of the Model 1100 Sporting shotguns.
 - c. Also touched on the increased cost of targets, the 2018 banquet cost and the increased cost of prizes. Prizes for this year include shooting bags from Lonesome Charlie's, RTIC coolers, Browning knives, and silver money clips with the AFSA coin logo.
 - d. Discussed number of raffle tickets sold for the Kolar shotgun. 337 tickets were sold, and the goal was 500. The amount of tickets sold will still result in a profit for the Association. Further discussion between Brad Felton and the association regarding the amount of silver purchased for awards. The cost of approximately 200 ounces of silver and knives were about the same.
 - e. Motion was made by Jim Tiner to approve the Treasurers' Report as read and the motion was accepted by Jerry Wasson. Seconded by Ed Guterrez. Motion carried.
4. Secretary Darron M. Todd
 - a. Requested that members thank Tucson Trap and Skeet Club for their exceptional support and facilities. Asks the association to solicit bids from clubs that meet the host criteria for future ASSCs.

1. Dave Wood and Gary Hunter extensively researched alternate dates for the ASSC and no solution was found.

 - d. Presentation of bids closed.
